

1WORLD AERO TRAVEL AGREEMENT

Participants – This document governs the Agreement entered into by and between the following Parties: the “Charterer” and “Charter Company.” The “Charterer” is the individual or entity requesting the charter service from the “Charter Company” known and registered as “1World Aero, LLC.” Aircraft owned or leased by the Charter Company are operated under FAA Part 135 Air carrier Certificate #O57A322L This charter quote only applies to aircraft that are directly operated by 1World Aero, LLC.

Confirmation of the Agreement - 1World Aero’s charter quotes and associated aircraft and crew reservations will only be confirmed and made final upon reception of this document, which is to be returned by fax to 301-912-1988 once signed by the Charterer. 1World Aero will email confirmation of reception and then this document shall be considered a binding agreement by and between the two parties.

Prices, Payments, & Cancellations - All prices quoted are accurate and valid for 15 days, and thereafter are subject to change without notice. Full payment is due on the date of service. Payment may be made by credit card, or check. Any and all checks must clear prior to flight dispatch. Clients agree to personally guarantee payment of any check or charge returned or denied by the client’s bank or credit card company and of any consequent penalty fees. A 50% deposit is required to hold the reservation.

1World Aero’s cancellation fee is 25% of the quote if the Charterer provides less than 48 hours notice, or 50% of the quote if cancellation notice is given within 24 hours of the flight.

No fees will be charged if cancellation is initiated by 1World Aero due to weather or mechanical circumstances. Any prepaid deposits may be applied to any required alternative charter arrangements if 1World Aero is unable to complete the charter on the reserved flight date. If alternative transportation arrangements can not be secured, any prepaid deposits shall be returned to the Charterer without delay and this agreement shall then be considered terminated.

Quotes specify all company charges, including landing and handling charges and fuel surcharges where applicable. Unspecified, personal charges to the Charterer such as

catering, limosine services, and rental cars shall be additional to the quote, and shall be the Charterer's responsibility unless included within the quote.

Additional charges of \$25 per hour, per crew member, for crew wait time beyond the waiting period detailed in 1World Aero's quote will be applied and added to the total trip charge.

Documentation - Verification of valid state or federal photo identification by 1World Aero staff is required for each passenger prior to boarding of the flight. Any documentation required for travel to the destination is the responsibility of the Charterer.

Notice of Schedule Adjustments - Though permitted, notification of needed adjustments must be transmitted in writing by Fax to 301-912-1988 or by email to N771TR@aol.com. Adjustment requests will be honored subject to 1World Aero's crew and airplane availability where such changes do not conflict with, nor impact other trip reservations.

Unplanned schedule adjustments impacting subsequent trip reservations with other clients will incur a charter conflict fee of 25% of the already dispatched charter quote if the next charter is caused to depart late, and 50% if the subsequent charter must be rescheduled or cancelled.

Responsibility - 1World Aero, LLC shall not be liable for any passenger's injury, delay, damage, loss, or expense caused by any factor not under 1World Aero's full and direct control, to include: sickness, weather, strikes, acts of violence, acts of God, quarantine, and to include mechanical failure or personal or corporate negligence by other individuals or corporations accepted, hired, or contracted to assist with the successful conveyance of the Charterer.

If the flight can not be completed due to weather, passenger physiological, or mechanical complications, then 1World Aero shall make every effort to arrange comparable transportation, however such arrangements are not guaranteed, and may require extra expense from the Charterer in order to be secured. Our liability shall be limited to the amount paid to us, and any claim shall be adjudicated in and governed by the laws of the state of Maryland, our principal business location.

Partial Completion of Flights - 1World Aero is not liable for additional expenses

incurred for replacement transportation in the case of mechanical complications. If a flight does not reach its destination due to weather, charges apply to any destination reached and the return flight of the aircraft and crew (with or without passengers) to home base. In the case of mechanical complications, 1World Aero may at its option provide substitute transportation which shall be charged as an additional fee to the Charterer. In such cases 1World Aero's original charges apply only on portions of the flight completed. Further alternate transportation charges for flight to the charter destination shall either be paid to 1World Aero or to the alternate charter service.

Pets - Pets must be carried in cages. Such transport is subject to approval by 1World Aero.

Passenger Info - All passenger names, weights, and ages, as well as baggage weights and dimensions shall be transmitted as soon as practical to 1World Aero to prevent flight delays or terminations due weight and balance complications.

Hazmats & Medical Oxygen - Hazardous materials and medical oxygen may not be transported on 1World Aero charter flights.

Brokered Flights - Aircraft contracted from another carrier are operated under their respective FAA Part 135 Air Carrier Certificates, in which case Charterer shall hold harmless and shall indemnify Charter Company against any and all losses. Clients representing themselves as brokers or other carriers are responsible for collection and remittance of applicable Federal Excise Taxes.
